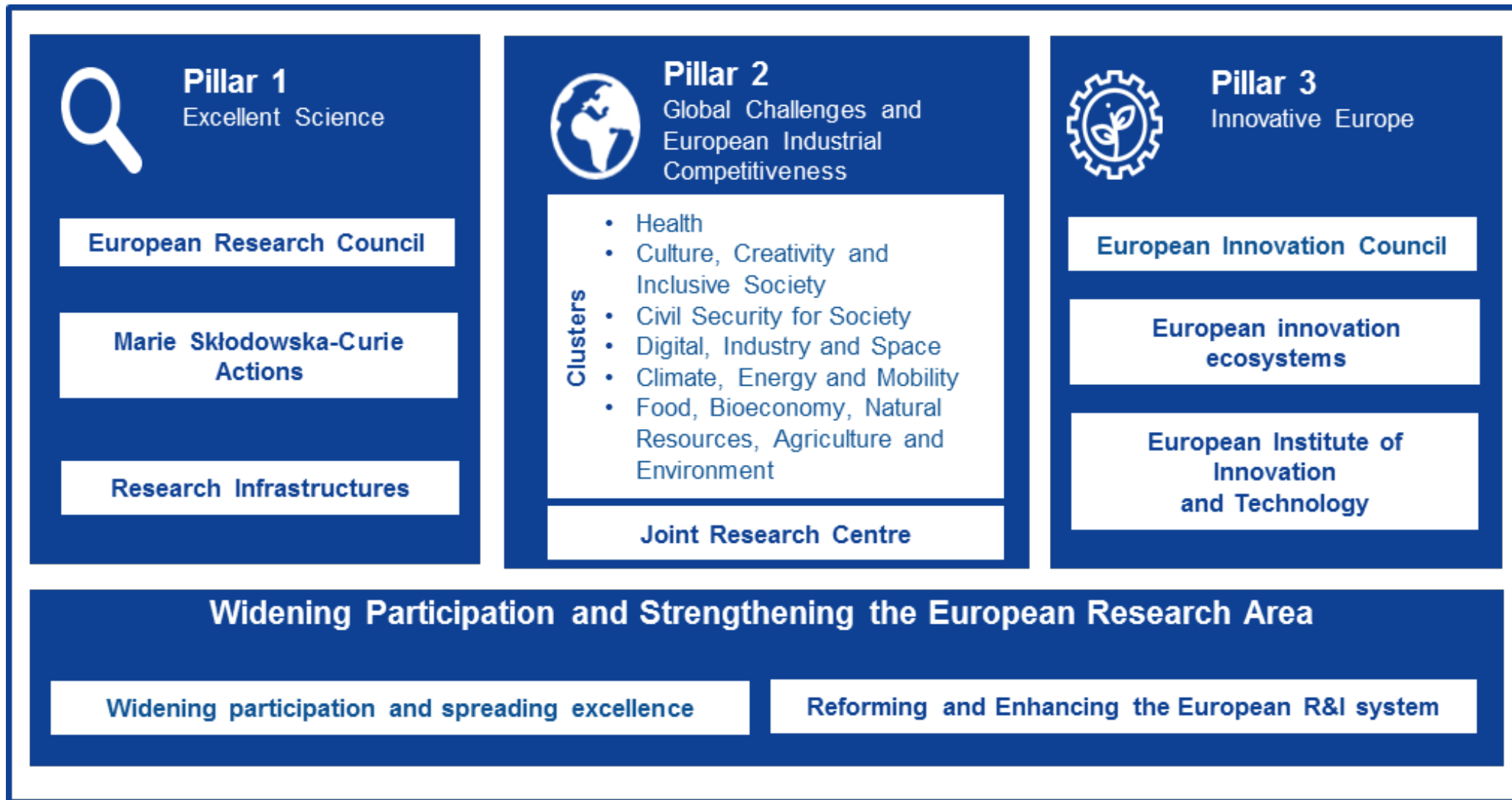

BE position paper on SSH integration (2018)

- Expertise of SSAH needed for tackling societal challenges at all stages of the development, implementation and monitoring of the framework programme
 - Research design of actions must be SSAH driven whenever relevant
- Huge disparity between the different pillars and challenges of the programme (most SSAH in the least funded SC6)
- Call 2015: SSH successfully integrated in 31% of the SSH flagged topics
- Lack of disciplinary diversity

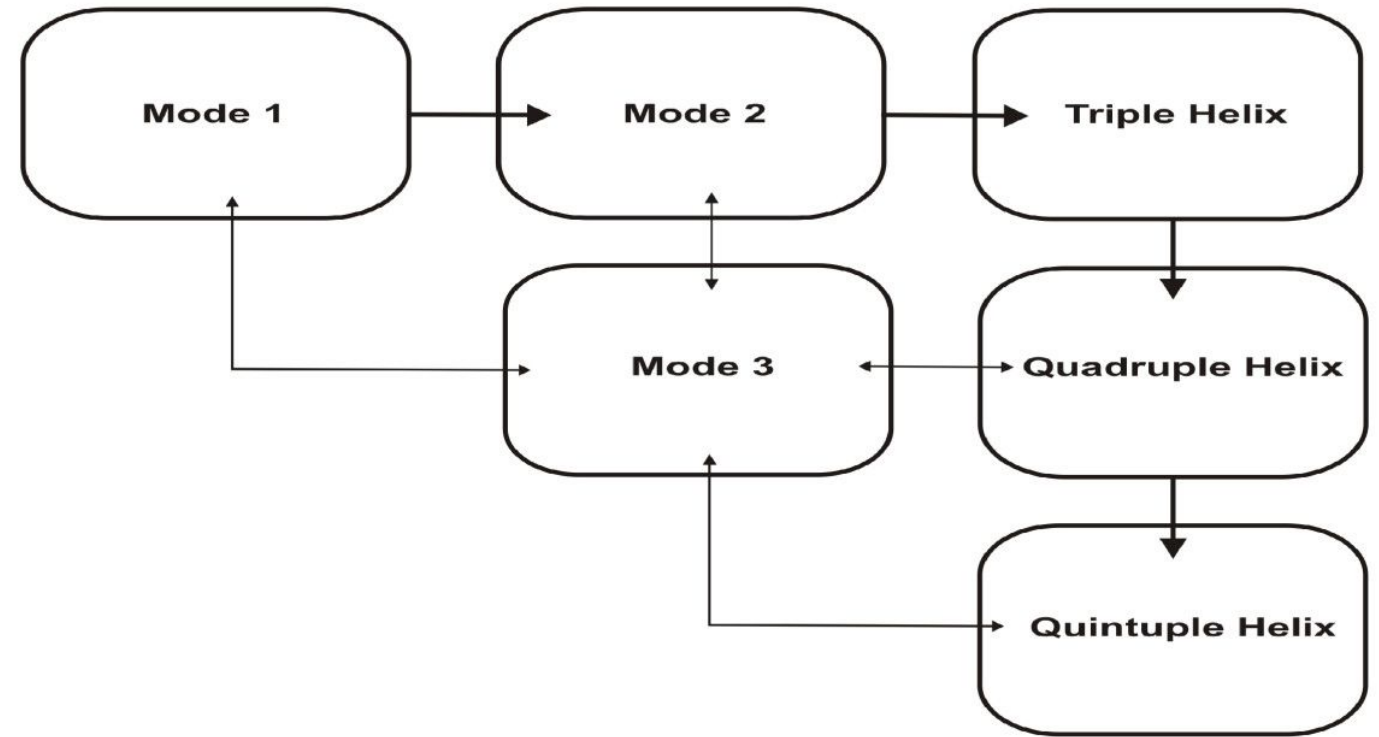
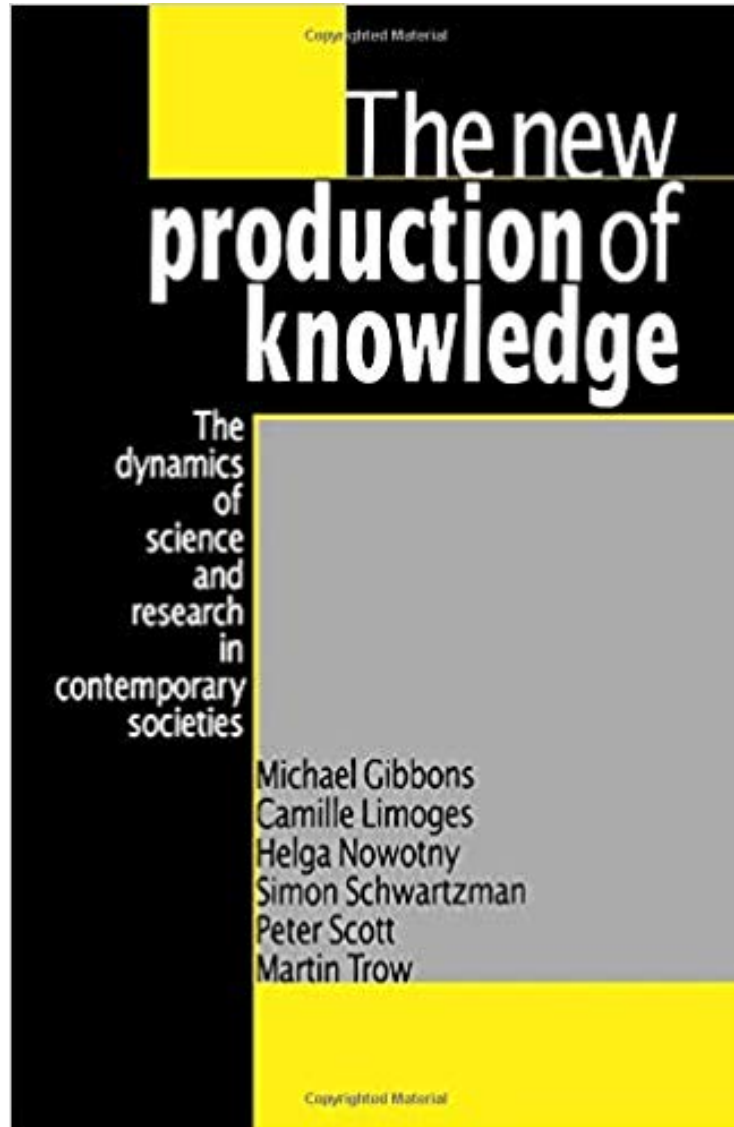

Some helpful tips (1)

- Read the impact section of the action very carefully!
- Don't consider (expected) impact as something unrelated to your research
- Think about the scalability of the impact
- Align expected impact with the Commission « key policy goals »
(Or at least take them strongly into account)

Some helpful tips (2)

- Keep following EU developments!
 - **The Sibiu Declaration:** conclusions of European summit
= vision for EU for next few years
- 1) A Protective Europe, concerning security and defence policy
- 2) A Competitive Europe, which focusses on research and innovation, new technologies, digital capacities and industrial policy
- 3) A Fair Europe, which centres on social inclusion, health, rule of law and fundamental rights
- 4) A Sustainable Europe, regarding sustainable development, climate change, circular economy and energy
- 5) An Influential Europe, dealing with international cooperation, promoting European values and standards

- Consortia of partners (min 3) from different countries, industry and academia

- **Innovation actions**

- *EU funding rate – 70% (except non-profit, which are still funded 100%)*
- Activities directly aiming at producing plans and arrangements or designs for new, altered or improved products, processes or services.

- Populism, radicalisation from the angle of inclusive and reflective societies
- Necessary to discuss the results with the policy makers (not waiting for the end of the project)

- DG RTD: Big challenges are:
 - Trust in institutions and mass parties
 - Different forms of political participation
 - Link between inclusion and political participation
 - Security related questions
(SC6= preventive part – DG HOME= curing part)
- DG CNECT about the RIA on new forms of delivering public goods and inclusive public services: “We do not have concrete percentage how much of the projects should be research, how much innovation. **We want solutions, we want something that works.**”

“Knowledge from transnational social sciences and humanities research, and insights in how culture can shape societies, will allow to assess past *and* present policymaking on political, socio-economic *and* cultural repercussions of innovations *and* inform future policy-making on alternatives.”

- “Encouraged”

“The incorporation of historical and comparative insights from migrant integration processes in relevant non-European societies is *strongly encouraged*. [...] Cooperation with non European scholars is also *encouraged*. ”

- “Could”
- TRANSFORMATIONS-04-2019-2020: Innovative approaches to urban and regional development through cultural tourism

“Minority cultures and regions as well as urban areas currently less attractive to cultural tourism should receive special attention in proposed strategies and pilot activities. [...] Strategies for cross border cooperation might look beyond EU Member States and Associated Countries and *could* preferably include partnerships between EU and non-EU countries of the Balkans, the Eastern neighbourhood or the Mediterranean.”

- **Closing date:** 12 March 2020

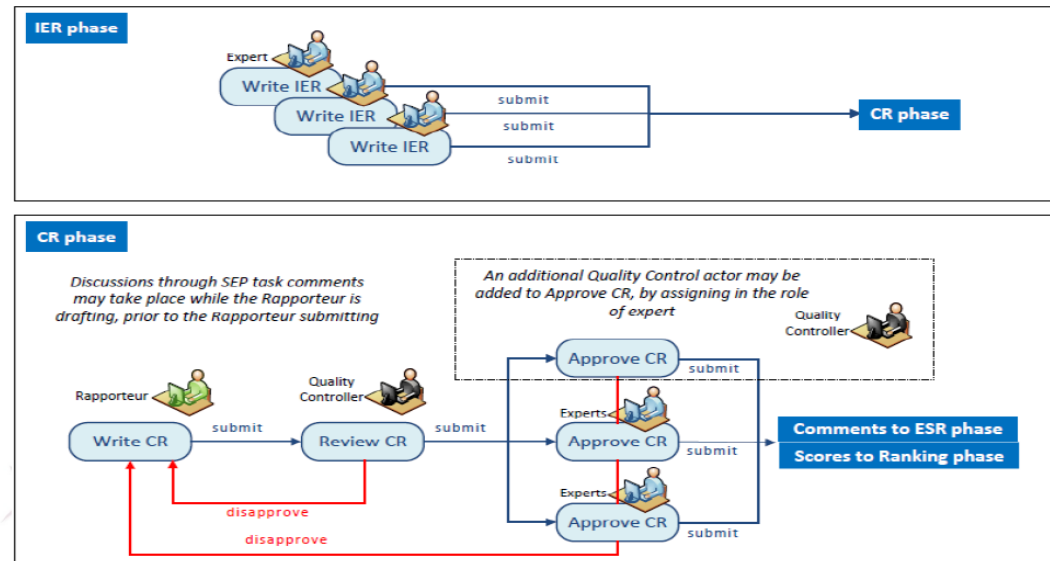

An evaluator's perspective

- My experience as an expert (IER, CR + Panel)

 - (2) RIA / Call: H2020-SC6-GOVERNANCE-2018-2019-2020 GOVERNANCE FOR THE FUTURE

Experts roles in SEP



Actions and evaluations criteria

- Types of actions
 - ▶ **RIA (Research & Innovation Actions)** - activities aiming at establishing new knowledge and/or to explore the feasibility of a new or improved solution (technology) product, process, service).
 - ▶ **CSA (Coordination & Support Actions)** - Action that improve skills, mobilise large – scale investments or facilitate EU policy implementation (‘systemic support of citizen science’)
- Evaluation criteria
 - ▶ **EXCELLENCE**
 - ▶ **IMPACT**
 - ▶ **IMPLEMENTATION**

Scoring

- Scores must be in the range 0-5.
- **Interpretation of the score:**
 - 0–The **proposal fails to address the criterion** or cannot be assessed due to missing or incomplete information.
 - 1– **Poor**. The criterion is inadequately addressed, or there are serious inherent weaknesses.
 - 2– **Fair**. The proposal broadly addresses the criterion, but there are significant weaknesses.
 - 3– **Good**. The proposal addresses the criterion well, but a number of shortcomings are present.
 - 4– **Very good**. The proposal addresses the criterion very well, but a small number of shortcomings are present.
 - 5– **Excellent**. The proposal successfully addresses all relevant aspects of the criterion. Any shortcomings are minor.

Excellence

- The following aspects will be taken into account, to the extent that the proposed work corresponds to the topic description in the work programme:
 1. Clarity and pertinence of the **objectives**
 2. **Soundness of the concept**, and credibility of the proposed **methodology**
 3. Extent that proposed work is **beyond the state of the art**, and demonstrates **innovation potential** (e.g. ground-breaking objectives, novel concepts and approaches, new products, services or business and organisational models)
 4. Appropriate consideration of **interdisciplinary approaches** and, where relevant, **use of stakeholder knowledge and gender dimension** in research and innovation content

Impact

- The following aspects will be taken into account:
 1. The extent to which the outputs of the project would contribute to each of the expected
 2. Any **substantial impacts not mentioned in the work programme**, that would enhance innovation capacity, create new market opportunities, strengthen competitiveness and growth of companies, address issues related to climate change or the environment, or bring other important benefits for society
 3. Quality of the proposed measures to:
 - **exploit and disseminate the project results** (including management of IPR), and to manage research data where relevant
 - **communicate** the project activities to **different target audiences**

Implementation

- The following aspects will be taken into account:
 1. **Quality and effectiveness** of the work plan, including extent to which the resources assigned to work packages are in line with their objectives and deliverables.
 2. Appropriateness of the **management structures** and procedures, including risk and innovation management.
 3. **Complementarity of the participants** and extent to which the consortium as a whole brings together the necessary **expertise**.
 4. **Appropriateness of the allocation of tasks**, ensuring that all participants have a valid role and adequate resources in the project to fulfil that role.

General comments

- **NO SUSPENSE** – Explain your concept, objectives etc from the very beginning
- **Avoid vague, general statements at all costs** - details, details, details. You should be consistent and specific (avoid imprecisions) but not repetitive
- Your project should be straightforward. Make sure that texts, graphs are clear and really **convey your message**.
- **Use H2020 vocabulary** (soundness of concept, management plan, work programme, target audience etc...)
- **Make the evaluator's task easier**. Use colors, graphs, etc. -. If you can use table for some content - use it (eg. risks, communication measures, etc.),
- Don't mention anything without **explaining HOW** it will be taken into consideration concretely.
- Good quality English will lessen the potential confusion. It should be obvious, but is sometimes not.

General comments

- **Don't overdo the scientific language** – otherwise we'll start to doubt whether you're able to engage citizens with less scientific literacy
- + **Don't forget that expert will not necessarily be expert in your very specific field**
- **Check the work programme again and again** and try determine the scope of it
- **Use the evaluation grid as a check list** to make sure that everything is addressed in your proposal.
- Don't focus on aspects that are not part of the evaluation criteria. They will be dismissed by quality check (apart from specific criteria).

- ▶ Project is financed in call
 - ▶ MIGRATION-01-2019 Understanding migration mobility patterns: elaborating mid and long-term migration scenarios

- ▶ Problem Statement:
 - ▶ A deeper understanding of the root causes and drivers of migration and of their interrelation with people's propensity to migrate is needed as well as projections and scenarios that are essential for appropriate planning and effective policymaking.

- ▶ The project's overall objective is to improve understandings of changing nature of migration flows and the drivers of migration, to analyse patterns, motivations and new geographies.
- ▶ Projects ambitions are to identify the uncertainties and reappraise, to explore the reasons why migration predictions may not hold and to demonstrate non-traditional data sources for migration research.

▶ HUMMINGBIRD will

- ▶ identify the uncertainties and reappraise
- ▶ explore the reasons why migration predictions may not hold

- ▶ listen to the migrants on the way to understand the root causes of migration
- ▶ use Big Data as proxies for migration measures
- ▶ examine possible future implications of today’s policy decisions

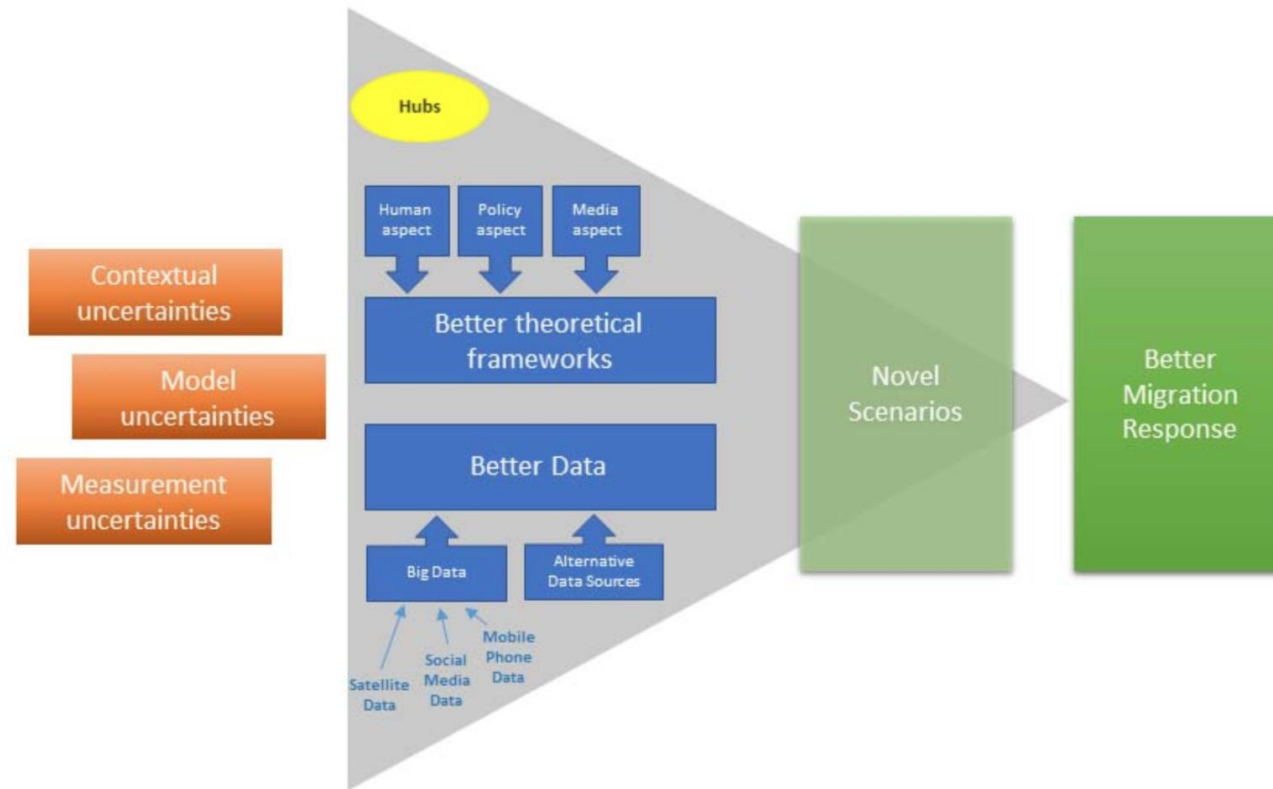


Figure 1 Overall Conceptual Flow of HumMingBird

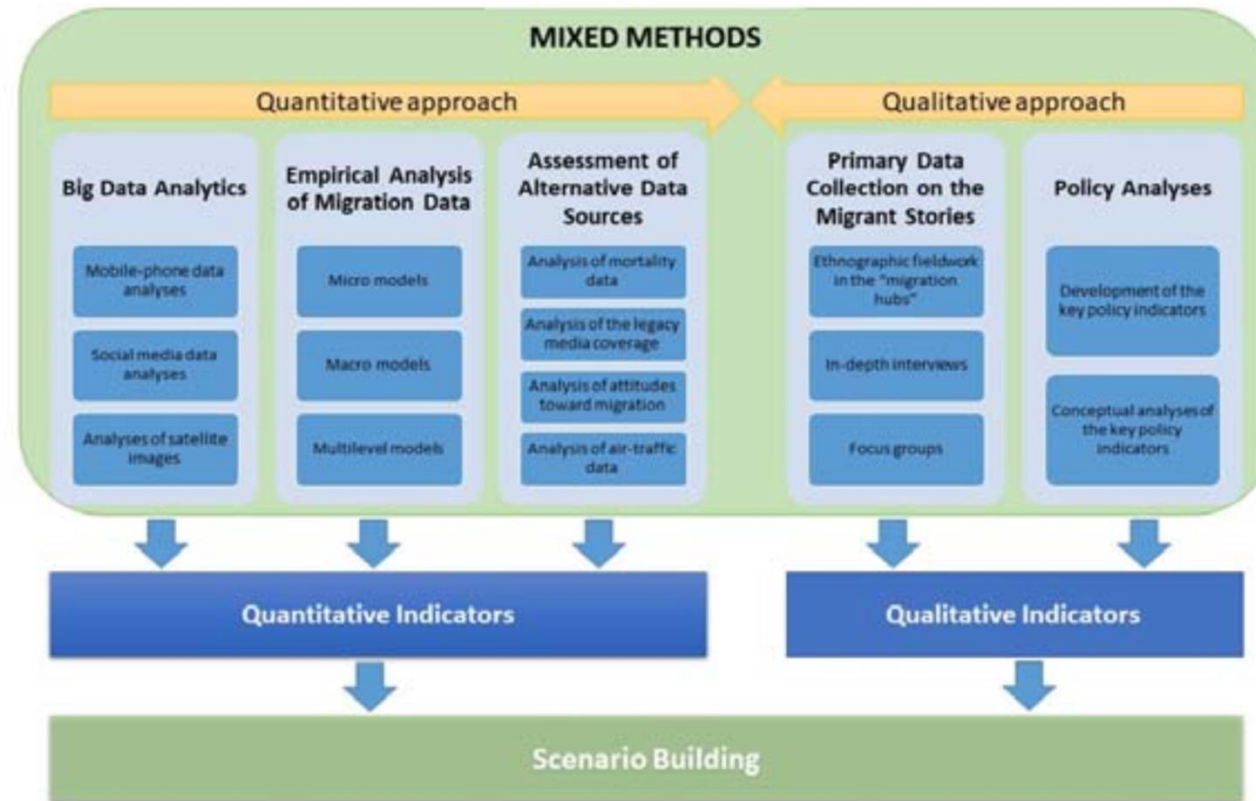


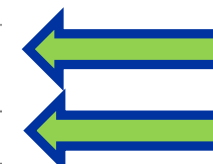
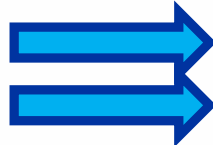
Figure 2 Methodology Flow of HumMingBird
